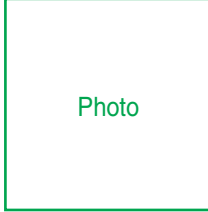

7. All **KRRS & HRC** members should contact their respective Area Units/ State Units / State Admn. Office once in a month.
